THE ROLE

Reporting to the Head of Analysis & Evaluation, the lead economist will specialise in assessing the impact of regional projects. With an excellent background in economic development, including economic modelling, business case development, or appraisal, you will help ensure that we design projects that achieve results, and take decisions to provide good value for money. You will be adept at working at the boundary between policy and analysis thinking.

You will be responsible for:

- Leading wide-ranging research and analysis of how to deliver the Metro Mayor's priorities in driving growth, equality and net zero
- Assessing how far strategic proposals will achieve our objectives, including for the forthcoming Local Growth Plan;
- Developing and maintaining a framework for business case authors to articulate the impact of proposed projects;
- Assisting project managers to ensure that they provide an intelligent client where development of schemes is being undertaken by consultants; and
- Reviewing business cases and providing assurance of the benefits set out.

KEY RESPONSIBILITIES

The Lead Economist will inform the Mayoral Combined Authority's spending decisions by leading work to understand how regional action can achieve growth, equality and transition to net zero. By developing robust evidence of how our projects will drive change, and estimating the impact of proposals, you will ensure that our spending decisions achieve our objectives and provide high value for money.

You will be responsible for:

Supporting the development of impactful proposals by designing and leading research to shape action on the region's priorities

Modelling the growth impact of strategic proposals

- Working closely with policy colleagues to identify how strategic proposals will affect the region's goals
- Modelling the potential scale of benefits and cost, to inform decisions on prioritisation

Raising the quality of benefits estimates in business cases

- Setting expectations for business case authors to adhere to in writing the economic case
- Providing advice and guidance on suitable approaches to modelling impacts
- And assisting project managers to ensure consultants provide high-quality assessments, particularly for transport schemes

Providing assurance of business cases

 Working with colleagues across the organisation, review business cases submitted for funding, to test the impacts set out and guide decision-makers on the value for money the proposal provides

You will work across all the Mayoral Combined Authority's areas of responsibility, and will work closely with policy and delivery colleagues to ensure that your analysis directly informs decision-making.

With a strong technical background in economic modelling and/or business case development, you will have the ability to work across topic areas and with a wide range of non-analytical stakeholders. You will use your excellent understanding of the policy environment and economic development techniques to influence change. And your demonstrated ability to drive forward work independently and implement new systems and processes will be essential as our organisation grows and develops.
