### BACKGROUND

The West of England Combined Authority is seeking to appoint an Industrial Decarbonisation Project Manager to join the Climate Strategy team.

## THE ROLE

Reporting to the Climate & Natural Environment - Funding & Investment Manager, the Industrial Decarbonisation Project Manager will lead on plans to tackle industrial carbon emissions in the region within the Environment Directorate.

As a member of our Climate Strategy team, you will work with public sector, private sector and academic organisations to develop a roadmap to net zero for industry, facilitating cooperative working between a range of stakeholders to deliver a clear, evidenced, viable decarbonisation plan to tight deadlines.

In collaboration with a range of project partners and subject matter experts, you will analyse the industrial energy use and associated carbon emissions in the region, and consider a range of solutions to tackle this, including fuel switching, carbon capture, heat networks and hydrogen/efuels, among others. By exploring the opportunities and barriers that these present, and underpinned by robust data analysis and future scenario planning, you will manage a project to identify the optimum carbon reduction pathway.

Focussing on practical solutions, you will see the big picture, but will also break it down into real world deliverables, identifying individual workstreams that are needed to successfully reach net zero. Using your knowledge, experience and skills you will drive forward a multidisciplinary team, building trusted relationships with key individuals to exploit their wealth of knowledge and experience, bringing them together to form one overarching plan. This will include managing procurement of external expertise and team leadership, albeit no direct line management is envisaged.

Working with our communications and stakeholder management partners you will ensure this plan is clearly articulated and fulfils the needs of all involved; identifying how it can be taken forward over the coming years as a series of work packages for successful implementation.

#### **KEY RESPONSIBILITIES**

- Lead a c.£750k project to develop an industrial decarbonisation plan and ensure delivery against project objectives and milestones.
- Keep track of project finances, ensuring that budgets and forecasts are communicated and agreed both internally and externally, and that correct and timely submission of valid grant claims are made.
- Report both internally and externally to key stakeholders to update on progress and attend board meetings as appropriate.
- Create, manage, and update project documentation including timelines, risk registers, etc. and ensure project delivery to tight deadlines.
- Escalate project risks, as and when required, to management and stakeholders.
- Build constructive and positive relationships with key stakeholders and act as the central point of contact for the project.
- Review options for reaching net zero and work with technical experts to ensure the optimum path is achieved based on evidence and data analysis.

- Support the Funding & Investment Manager to secure further funding for the exploitation of the decarbonisation plan, as required.
- Support the wider work of the Environment Directorate and the Mayoral Combined Authority as required.
- Act as an ambassador for the Environment Directorate and the Mayoral Combined Authority in all interactions with external stakeholders.

### Qualifications and Knowledge

- Educated to degree level or with equivalent work experience.
- Professional qualification in project management and/or equivalent experience in project management, ideally applied in the energy sector.
- Knowledge of the wider climate and nature emergency and national, regional, and local responses to it.
- Substantial knowledge of net zero energy solutions including an understanding of the organisational, legal and economic issues affecting industrial carbon reduction project viability and delivery.
- Knowledge of contractual requirements of public funding.

- Significant experience of managing large-scale projects with competing demands, to tight and varying timescales, including the design and delivery of projects.
- Significant experience of communicating (oral and written) with a wide range of people, including internal and external stakeholders; and of explaining technical/complex information in an easy-to-understand manner.
- Significant experience of financial management of projects, such as ensuring budgetary thresholds are not breached and cashflow is accurately profiled.
- Experience of leading and managing multidisciplinary teams including technical experts, industrial partners and governmental organisations.
- Experience of using diagnostic tools, data and evidence to aid decision making.
