The West of England Combined Authority is seeking to appoint a monitoring and evaluation officer to join the Analysis and Evaluation team. This is an exciting time to join the West of England Combined Authority. In the last year nearly three quarters of a billion pounds of new investment has been secured for the region.

New plans are in place to deliver on Mayoral priorities to improve transport, skills and housing for our residents, take decisive action to tackle the climate emergency, and to support communities facing the cost-of-living crisis. There is a relentless focus on delivery to put the West of England on the map for regional, national and global success.

Led by the regional Metro Mayor, the West of England Combined Authority brings together three local councils, the Local Enterprise Partnership and works with communities, other public services, and industry to deliver for the region.

THE ROLE

Reporting to the Principal Economist, the Monitoring and Evaluation manager will be responsible for ensuring that the Combined Authority effectively tracks and evaluates our delivery (in line with the Metro Mayor's ambitions.) The Combined Authority's programmes and projects have grown significantly in recent years, and (the Metro Mayor wants a real focus on delivery) so this is an exciting opportunity to strengthen the way we learn from delivery and to influence our future plans.

As the Combined Authority's lead on monitoring and evaluation, you will work with project managers across the Authority's teams, covering transport and infrastructure, business support, skills, and environment. You will be ambitious in identifying the strategic questions our evaluations should address, and collaborative in working with programme and project managers to identify the lessons.

With a strong monitoring and evaluation background, the successful candidate will join the Combined Authority at an exciting time as we work with our partners to consolidate delivery of projects to build the economic and environmental resilience of the region."

KEY RESPONSIBILITIES

You will be responsible for developing and maintaining the Combined Authority's approach to monitoring and evaluation, and supporting our programmes to adhere to it. Building our evaluation expertise, your specific responsibilities will include:

• updating the Combined Authority's Monitoring & Evaluation Framework, ensuring it is robust across our activities and provides clear guidance to project managers;

• developing a framework of output and outcome measures for the Combined Authority's

programmes, so we can track our progress against the Mayor's priorities and funding agreements;

helping shape the evaluation requirements for our ambitious transport settlement;

• providing advice and assessing monitoring and evaluation design at project initiation;

supporting project managers to conduct evaluations, guiding research design, supporting consultant research, and working with the analysis team to conduct small evaluations internally; and
ensuring that the lessons from evaluations are identified and shared within the Combined Authority and with partners, so that they can be incorporated into future plans.

The monitoring and evaluation manager will work closely with stakeholders across the Combined Authority and our partner organisations. This will include both corporate teams including Grant Assurance, the Programme Management Office, and Policy team, and project delivery teams. The manager will also help the Combined Authority meet its reporting requirements from funders, including through the Government's Gateway Review of our investment funding settlement.

As a new role, this post offers a significant opportunity to shape the way that the Combined Authority reflects on its work and integrates learning into future strategy and policies
